Applications are being accepted for the Surface Transportation Program (STP)-Urban, STP-Rural, STP-Local and Local Bridge Improvement Assistance programs.

The Bipartisan Infrastructure Law (BIL) is expected to provide significant increases in federal transportation funding for the next five years, beginning with FFY22. Time is of the essence in planning for the use of FFY22 federal funding. The Federal Highway Administration (FHWA) requires FFY22 funding to be obligated by September
